VIII Unfinished Business:

- a. Discussed the planned visit of Tracy Tomaszewski (EGLE). Supervisor Eitrem announced that Ms. Tomaszewski was in a vehicle accident and was unable to attend her previously scheduled appointment. Plans are to reschedule at a later date. Supervisor Eitrem will tour the island, taking photos of sites in preparation of her visit.
- b. Discussed recent legal review of the Township's Advertising Sign Ordinance. **MOTION:** Trustee Morehouse to eliminate Sign Ordinance. Support Trustee Williams. Motion passed Unanimously
- c. Discussion regarding public question and answer session with Spectrum Communications on August 26th at 6:00 pm at Sugar Island Township Community Center. Steve Gillis will let the board know if the Lions Club will offer refreshments after the Lions meeting this Thursday.

IX New Business:

- a. Pay Bills with EFT's and Checks.
MOTION: Clerk Rich to pay monthly bills as presented. Supported by Supervisor Eitrem. Motion passed unanimously.
- b. **MOTION:** Supervisor Eitrem instructed the Planning Commission to engage for the purpose of creating an ordinance to address solar and wind farms. Support Trustee Morehouse. Motion passed unanimously.
- c. Discussed and considered the need to increase Community Center rental fees. Treasurer Brown and Supervisor Eitrem will continue to gather information from other townships to be presented at a later meeting.
- d. Discussed and considered the need to increase the pay for the Township's elected officials. Supervisor Eitrem will contact other Township Supervisors to gather information for future discussions.
- e. Discussed and considered the need to issue permits for food trucks and other private vendors using the Township's facilities. Primary concern – fire safety. Fire Chief Horner will explore possibilities regarding permits/inspections.
- f. **MOTION:** Supervisor Eitrem to follow all State retention and Disposal Schedules to authorize disposal procedures. Support Trustee Morehouse. Motion passed unanimously

X Department/Committee Reports:

- a. Ambulance Report -July 1, license renewed x 1 year.
- b. Fire Report -4 runs, 1 medical assist, volunteer training continuing as scheduled. Jaws of life, value ~\$1,000, will be donated to the EUP Fire Academy.
- c. Planning Commission- unable to hold a recent meeting due to a lack of quorum, Trustee Carol Williams is in the process of recruiting the required number of members.

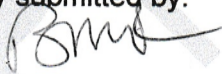
Discussion – Trustee Morehouse regarding Beach Safety signage. General consensus to utilize a purchase order and order appropriate signs.
